

Spirit of Cricket Code of Conduct

I, as a participant in events held by Spirit of Cricket Global Pty Ltd (SOCG), such as Spirit of Cricket Tournaments, commit to upholding high standards of sportsmanship, fairness, and respect for fellow players, coaches, officials, and spectators. I understand that my behaviour on and off the field should reflect positively on the Spirit of Cricket.

I agree to:

- 1. Compliance with Rules: Follow all rules and regulations set forth by SOCG for the competition.
- 2. Respect for the Game: Not bring SOCG Competitions or the game of cricket into disrepute.
- 3. Spirit of Cricket: Respect the spirit of cricket and fair play and behave accordingly in the spirit of the game.
- 4. Respect for All: Display and encourage respect for umpires, opponents, coaches, administrators, officials, parents, and spectators.
- 5. Acceptance of Decisions: Accept the decisions of the officials and referees with grace, even if I may disagree with them.
- 6. Emotional Control: Control my emotions and refrain from verbal abuse, swearing, sledging, or any behaviour that deliberately distracts or provokes an opponent.
- 7. Non-violence: Never engage in any type of violence on or off the field.
- 8. Creating a Safe Environment: Contribute to a safe sporting environment and respectful culture that accepts individual differences.
- 9. Team Cooperation: Cooperate with Franchise Officials, Coaches, and teammates.
- 10. Enjoyment of Participation: Participate for my own enjoyment and for the benefit of my teammates, coaches, and franchise officials.
- 11. Anti-bullying: Not take part in any form of bullying, including via social media.
- 12. Non-discrimination: Never discriminate against any person based on gender, ability, sexual orientation, cultural background, race, or religion.

- 13. Ethical Conduct: Not engage in or encourage conduct that is unethical, unbecoming, or likely to harm the reputation of myself, my team, my franchise, or SOCG.
- 14. Responsible Social Media Usage: Not make or post inappropriate, offensive, or discriminatory comments in public, including on social media, about other players, competitions, franchises, umpires, officials, or any SOCG Competitions.
- 15. Integrity Reporting: Report to the SOCG Competitions Integrity Team any approaches to fix matches or any behaviour that may compromise the integrity of the competition.
- 16. Sobriety: Never participate in SOCG events if knowingly under the influence of drugs or alcohol.

Commitment to Participation

I understand that participation in SOCG events requires dedication and commitment. I commit to attending practices, matches, and other team-related activities regularly and punctually. I understand that my commitment is essential for the success of the team and the overall experience of the competition.

Information Privacy

I acknowledge that SOCG may collect and use personal information provided in this waiver for the purposes of organizing and managing cricket competitions. SOCG will not disclose this information to third parties without consent, except as required by law.

Waiver of Liability

I voluntarily assume all risks related to my participation in SOCG events and release SOCG, its officers, officials, coaches, volunteers, and affiliates from any claims arising out of my participation.

Photography and Video Consent

I consent to the use of photographs and/or videos of myself or my child for promotional purposes by SOCG. I understand that I have the right to revoke this consent at any time in writing.

I understand that failure to adhere to these terms may result in disciplinary action, including but not limited to suspension or expulsion from the team and competition. This decision will be governed by the Spirit of Cricket Global Pty Ltd.
